COLLECTON & STORAGE OF INFORMATION

Registration at Manodarpan require user/s to share their personal details including but not limited to name, father's name, address, e-mail address, mobile, school, class, stream, area of interest etc., which may be used by Manodarpan.

Is approved for release upon the written permission of the Manodarpan;

Is required to be disclosed to a government/ judicial/ quasi-judicial body in pursuance of an order.

In such events, where possible, the user shall give adequate notice to the Manodarpan, as the case may be, before making any disclosure so that the Manodarpan may have adequate opportunity to respond prior to such disclosures; as also make disclosures only to the extent as required.

Further, you agree and undertake:

That all the Confidential Information shall be considered and shall remain a trade secret and the sole property of Manodarpan;
